

Annual Report 2017-2018



Since 2010, we've developed open source software tools and provided technology services to help defend and promote universal human rights on the Internet. We specialize in solutions that enable and promote freedom of speech and association online, as well as the right to privacy and equal access on the Internet.

Overall this was a tough year for upholding human rights on the Internet. Network level censorship is becoming more widespread and the technology enforcing it, difficult to circumvent. Web layer attacks continue to silence independent voices. In the midst of this regression, eQualitie stood firm to its principles and mission.

Negative trends included state surveillance and "innovative" control mechanisms (for example China's "social score" and Russia's "Yarovaya package") paint a bleak picture for the future. Network interference has become a commodity and in-country ISPs are now able to buy equipment which does all of the complicated dirty work for them. Targeted attacks against websites can be purchased online from multiple 'stresser' services. These attacks muzzle online voices and act, with impunity, as another form of censorship.

On the other hand, we are witnessing large media organizations promoting and collaborating on anti-censorship tool development. We also welcome the introduction of privacy features to popular communication tools. For example, several billion smartphone users this year, have access to encrypted messaging services after Facebook Messenger, Google Allo and Whatsapp implemented the Signal protocol from Whisper Systems.

Our work this year has focused on softening the blow and countering some of these threats. We aim to level the playing field between the user and censor. To introduce eQualitie into the network!

One of the ways we've been working toward this goal is through our flagship product and service <u>Deflect</u>. This year we began to lay the foundations for a much stronger analytic approach to malicious behavior on the network. We are interested in harnessing machine lead technology to improve the classification of malicious vs benign behavior; to share threat data with our peers; and to remove the veil of impunity from those attacking Deflect clients.

In parallel, we began an effort to introduce the next generation of censorship circumvention technology, through the Ceno project. Utilizing existing peer-to-peer routing and distributed storage technology, we're bringing back the cypherphunk ideals and protocols to deal with some modern-day problems.

As part of our mission to increase security awareness and resources for civil society organizations and activists around the world, we have helped establish digital security training centres with partner NGOs. To date, these schools have been introduced for Belarus, Ukraine and Tunisia. This year we began working with Colnodo to develop a new center in Colombia. eQualitie provides guidance and expertise to develop training curricula and help introduce secure platforms and online services for training participants.







#### A message from the board

Threats to civil society are increasing and eQualitie's work to protect it has never been more relevant. Technology tools that are truly open, free and usable for journalists, activists and small grassroots organisations are absolutely critical.

The eQualitie team has expanded both in number and in expertise to be able to meet this critical need and it's truly and exciting time for us as a board to help guide eQualitie and ensure its stability through this expansion. # ICT SELECTION OF THE PROPERTY OF THE PROPERTY

Article 19 of The Universal Declaration of Human Rights

Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers

#### Freedom of expression & association

We believe that the ability to express oneself freely on the Internet, without hindrance and interference is a human right, protected by *Article 19* of the UDHR. Likewise we operate on the understanding that the right to peaceful assembly and association, protected by Article 20, also applies to a website's ability to serve information to its readers.

Cyber attacks that attempt to nullify these inalienable rights have lead us to create an infrastructure protecting online platforms and ensuring their continuous operation. Sophisticated network filtering technology deployed in various nation states to censor their citizens' access to the Web inspired us to develop new methods for helping users circumvent these restrictions.



### This was the sixth year of operations for the Deflect DDoS mitigation infrastructure. In 2017 we achieved the following milestones.

- Introduced our own statistics platform for live and historic traffic visualization
- Automate the provision and renewal of Let's Encrypt encryption certificates for Deflect clients
- Mitigated over a hundred individual attacks on the Deflect network
- Created a technical and marketing strategy for commercializing Deflect services
- Re-designed and rebuilt the Deflect documentation portal and website, linking it with the Transifex platform for localization
- Over 300 websites protected, serving on average one million daily readers

#### **Digital Security Schools**

Since 2011, eQualit.ie has helped establish digital security training centers around the world. Their purpose is to create local capacity for providing continuous education on Internet communications privacy, secure information handling and general computer, Internet awareness.

The schools work with local civil society organizations, including independent media and human rights groups. They are housed with a local country partner, an established NGO with an interest in developing this type of project and capacity. Our model is to provide financial assistance, technical support and pedagogical guidance for the first year of project operations. We believe this effort to be cost effective and targeted towards creating lasting change on the ground.

#### **Events**

#### eQualit.ie in Valencia

In advance of the Internet Freedom Festival we convened a team meeting to discuss architectural design decisions on the new iteration of the https://censorship.no project we embarked upon this year. During the festival itself, eQualit.ie presented the Deflect and (n+1)sec projects to large auditoriums as well as helping to host the Tools & Technology Showcase one more time.

#### ISP infrastructure meeting

In June we organized a meet up in Montreal for about 35 independent and ethical Internet service providers from around the world. Topics for the meeting included discussions on how to survive as an independent core infrastructure service provider; how to better share resources and facilitate access to secure hardware and servers; how to complement each other's software development efforts. We discussed better methods for collaboration including threat information sharing and fundraising. Rethinking the ways we use critical infrastructure is acutely important, considering the corporate state of the Internet today and the power several companies have over the network. We need to ensure that independent, secure and trustworthy hosting alternatives continue to exist. A report on the outcomes of the meeting will be published over the course of the next few months.

#### **Internet Freedom Conference**

Also in June we organized and hosted a conference in Montreal around the topic of Internet Freedom, for organizations and partners from our community. Topics and thematics included reporting back on our individual projects over the last year, progress made and difficulties encountered. We facilitated discussions and break-out sessions to share best practices in our fight for human rights in the digital age. Two panel sessions completed the program, discussing threats to human rights posed by restrictions to encryption and the ongoing debate of data transparency vs. data privacy.
